

PRIVACY POLICY

Al Wasl Water Purification LLC respects your privacy and is committed to protecting it through its compliance with its privacy policies.

1. Information You Provide to Us

1.1 Your Personal Information

Personal Information is the information that can be associated with a specific person and could be used to identify that specific person whether from that data, or other information that we have, or is likely to have access to. We do not consider personal information to include information that has been made anonymous or aggregated so that it can no longer be used to identify a specific person. We collect this information directly from you, which you have provided to us at the time of signing.

1.2 Your Account Information

Account information includes your full name, email address, postal code, mobile number, date of birth, password and any other information which we may ask of you.

1.3 Your browsing information

How long you used our Services and which features you used; the ads and tabs you clicked on, etc.

1.4 Your transactional information

If you make purchases through our Services, we may collect and store information about you to process your requests and automatically complete forms for future transactions, including (but not limited to) your phone number, address, email, billing information and credit or payment card information.

2. How we use the information we collect

We use the information we collect from and about you for a variety of purposes, including to:

- 2.1 Process and respond to your queries and provide you customer support.
- 2.2 Deliver our Services and diagnose technical problems.
- 2.3 Send you communications that you have requested or that may be of interest to you by way of emails, SMS or telephone calls, or any other mode of communication.
- 2.4 Notify you about any changes in our services.
- 2.5 For any other purpose, with your consent.

3. Payment Card Information

To use our online ordering services, we may require credit or debit card account information.

- 3.1 When you use a credit or debit card to secure a reservation through our Sites, we provide your credit or debit card account information (including card number and expiration date) to our third-party payment service provider.
- 3.2 The third party service providers with respect to payment gateway and payment processing are all validated as compliant with the payment card industry standard (generally referred to as PCI compliant service providers).

We will take reasonable steps to accurately record the personal information that you provide to us and any subsequent updates.

We encourage you to review, update, and correct the personal information that we maintain about you, and you may request that we delete personal information about you

that is inaccurate, incomplete, or irrelevant for legitimate purposes, or are being processed in a way which infringes any applicable legal requirement.
